2.1. Finance Report- Ryan gave the finance report. Our increase in spending this month was attributed to the quarterly insurance premium payments.

2.2. Facilities Report-

Facilities Report – Brian West, Facilities Manager

Brian provided an update on several ongoing and completed projects:

- Gutters New seamless 6-inch gutters have been installed on the Playground, Courtyard by the Pastor's office, and Sanctuary. Repairs were also made near Disciples Hall. Additionally, 155-gallon barrels will be added in the Playground area to capture excess water.
- East Sidewalks Construction is scheduled to begin on September 1 and is expected to be completed by September 13.
- Two broken sprinkler heads caused a large cavern under the concrete directly in front of the sanctuary. Brian W. will start working on bidding the concrete work, capping the sprinkler lines, and xeriscaping the grass.
- Parsonage Roof The contractor will provide Brian W. with a start date for the project.
- Little House The Stove has been replaced at the Little House. The pilot light was going out. When the replacement occurred, it was noticed that there was a gas leak. This was corrected with the new stove. Lane's Plumbing will replace the collapsed sewer line.
- Southside Building Roof Brian recommends a patch repair to the TPO roof. The bid for patching is \$1,700 compared to \$144,000 for a full replacement.
